

## SI Securities, LLC: Privacy Policy Disclosure & Consent

*Your privacy is important to us. SI Securities LLC (“the Firm” or “SI Securities”) respects and protects the privacy of its clients and partners. ### SI Securities’ Collection of Personal Information

In order to provide you with the best possible service and to meet our responsibilities to you, our other investment partners, and our business contacts, we may collect nonpublic personal information about you in the following ways: directly from you; from other affiliated entities; from your other financial or investment advisory firms; or from non-affiliated third parties. Information we collect may include your name, address, Social Security Number or tax identification number, financial account information, income, assets, net worth, account balances and account transactions, and personal or financial goals. SI Securities’ registered representatives and principals will have access to such information, and may disclose the information as described below.

### Disclosure of Your Personal Information to Affiliates in the Seedinvest Family of Firms

In the course of providing securities-related services to you, we may disclose the information described above to our affiliates. Our affiliates currently include Seedinvest Technology LLC, SI Selections Funds I, L.P. and Seedinvest LLC. We share information with our affiliates in order to provide you with the best possible service, to inform you of other services we believe you may desire to utilize, and to prevent fraud against you, other investors, or the Seedinvest family of firms. Please know that your information will remain secure at SI Securities because the Firm and our affiliates adhere to strict privacy procedures. You also have the right to explicitly opt out from receiving marketing solicitations from affiliates.

### Disclosure of Your Personal Information to Non-Affiliated Third Parties

We may also disclose the personal information described above to third parties that are not affiliated with SI Securities and our affiliates. We would do this in order to execute the financial services you have requested, investigate investment opportunities on your behalf, or for reasons otherwise permitted by law. We do not share personal information regarding former clients with non-affiliated third parties, however (unless we are required to do so by law). We currently disclose personal information to our clearing broker, Foliofn Investments, Inc.

## Affirmative Consent and Opt-Out Required

You have the right not to agree to our uses of your personal nonpublic information. In order to comply with applicable laws and to protect you and our firm, we require affirmative consent from all individual clients to these uses and disclosures of client information. You also have the right to explicitly opt out from receiving marketing solicitations from affiliates, as disclosed above. It is our policy not to provide financial services unless clients consent to our privacy policies by signing, dating, and returning the attached Privacy Policy Consent form to us.
